### **A. Since the last meeting the following applications have been considered.**

1. Houlston Manor Farm, Myddle – erection of a 30m high twin bladed turbine. No objections raised.
2. The Archways, Brookside, Myddle – erection of a dormer bungalow and changes to vehicular access. Objections raised on the grounds that individual applications for development negates the need for units of affordable housing.
3. Aquilla, Myddle – formation of new vehicular and pedestrian access. Concerns raised at (a) Visibility to left on exiting the property; (b) construction of a mini roundabout although it is accepted that it is private land.
4. White Meadow – approval of reserved matters relating to the erection of two bungalows. Objected to on the grounds that (a) the footprint of the new property is too large and also too close to the adjacent property; (b) Amount of glass in bedroom two which overlooks properties on the other side of Ellesmere Road.
