# 21/08 Minutes from the meeting held on March 6th. 2020:

The minutes of the meeting were approved and were signed by the Chairman as a true record.

# 21/09 Matters Arising:

## (a)Wem Road pavement

Members were advised that this pavement had been included in the plans for the housing development that had taken place on Wem Road but had not been constructed by the developer. The Parish Council had put pressure on the planners and the developer to have the work completed but no action had been taken.

Shropshire Councillor B. Williams had been giving support for the past eighteen months and confirmed that the issue was now going to be subject to an enforcement order.

# (b) Ellesmere Road pavement

This pavement had been included as part of the original plans for housing on the Red Castle Public House car park but had been omitted from the amended plans which had been approved. This issue had been raised by a resident and the Parish had been advised that to secure the work they would need a grant from the Community Infrastructure Levy. Before an application could be made but the Council needed Shropshire Council to provide a plan and an indication of the possible cost and had now been waiting nine months for this to be provided.

# (c) Play Area Inspections:

It was noted that Shropshire Council had appointed a new Play Ground Inspector and an annual contract had been agreed for six two monthly and the Annual RoSPA inspections. The Clerk had arranged to meet the new Inspector when the current Covid restrictions were lifted.

Under Covid restrictions some swing seats had been removed and it was decided that the Clerk should ask for these to be replaced.

## 21/10 Correspondence.

Members considered the details of the correspondence received by the Clerk since the last meeting and where appropriate responses had been or were made.

Concerns were expressed at problems being created to a local resident from low flying aircraft from Sleap airfield and Members asked if it was possible to have more details of the situation. Clerk to discuss with the resident who had raised the complaint.
