MYDDLE AND BROUGHTON PARISH COUNCIL MINUTES OF THE MEETING HELD IN HARMER HILL VILLAGE HALL ON WEDNESDAY MARCH 4^{TH} . 2010 AT 7.30PM.

Public Session:

There was one member of the public present who raised the following concerns:

- 1. Anti-social behaviour and litter by the entrance to the woods on Lower Road, Harmer Hill. Noise was generating from cars meeting there late in the evening causing disturbance to the local residents particularly on Sundays. There was also a problem with dog fouling along the verges of Lower Road in that area.
 Clerk was asked to contact the police and ask for patrol cars to visit the area and also ask the Street Scene Manager to have the litter collected and erect a dog waste bin in a location near to the gate.
- 2. The local hunt had agreed to inform residents in Harmer Hill when there was likely to be a drag hunt in the area. This enabled residents with livestock to house them for the duration of the hunt. No information had been given for the last two hunts. Clerk was asked to write to Mr. Thompson, reminding him of the assurance given.

09/75 Matters Arising:

1. Shropshire Council – Rural Community Development:

Members considered a response from Lois Dale (Shropshire Council) in which she offered to set up a local meeting to discuss issues. Mr. Williams pointed out that this was part of Shropshire Council's development process for providing a planning strategy for the next fifteen years.

A design statement was to be published on April 2nd which would detail the suggested development for each Parish and he felt that it was very important that Members considered this carefully, consulted with parishioners and responded in detail to any proposals for the Parish.

Members accepted his advice and agreed to meet at 8.30pm on April 28th. to develop a strategy for involving the public in any response made to the paper. The Clerk would send out a copy of the document to every Member as soon as he received it.

2. Snow clearance on footpaths.

Clerk gave details of the Shropshire Council's priorities for snow clearance, which at first dealt with A and some B roads, before moving on to the remaining B and C roads

(b) <u>Improved Lighting in the area by Myddle Church.</u>

It was decided that the Council would make a contribution to the project, if the Church decided to go ahead with the proposal and provided full details of the likely cost.

(c) Cleaning Debris from Myddle Brook

After discussion this proposal was withdrawn.

09/79 Employment of a part-time worker:

After detailed consideration it was decided not to proceed with this proposition but it was decided to try and engage a 'Preferred Contractor', who could be called on by the Clerk or the Chairman to carry out tasks which the Parish Council was responsible for, needed urgent attention and where the cost did not exceed £100.

09/80 Banking:

Members considered a report from the Clerk suggesting that new Bankers should be engaged to manage the Council's accounts as the current bank was now based in Wolverhampton and there was a need to register new signatories for signing cheques. It was unanimously agreed to make a transfer to the Royal Bank of Scotland (Shrewsbury Branch), in June. All Members present agreed to act as signatories.
