

**MYDDLE BROUGHTON AND HARMER HILL PARISH COUNCIL  
MINUTES OF THE COUNCIL MEETING HELD IN  
HARMER HILL VILLAGE HALL ON 3<sup>rd</sup>. SEPTEMBER 2025 AT 7.30 pm.**

**Public Session:**

There were seven members of the public in attendance and the following issues were raised:

- (a) The need for a 30mph speed limit on Wem Road, Harmer Hill.
  - (b) Failure of dog owners to collect and dispose of dog waste in area where children play even though the Council provided bags for collection and suitable bins.
  - (c) Continued concern about the inappropriate use of The Hollow Harmer Hill as a 'rabbit run'.
  - (d) Drainage problems causing problems to properties alongside Ellesmere Road, Harmer Hill, following the recent heavy rain although this had been dealt with quite promptly by Shropshire Council.
  - (e) Further information supporting the request for the closure of Footpath 67A.

**25/32 Apologies:**

Apologies were received from Councillor Mrs. J. Jackson.

**25/33 Disclosure of Personal or Prejudicial Interests:**

No disclosures were made.

**25/34 Minutes from the meeting held on 25 June 2025.**

Councillor J. Jackson had sent a request for a revision in the report of the issue raised in the Public Session regarding The Hollow, Harmer Hill, which she felt should read '*Several possible solutions were considered including a proposal that action could be taken to prevent access to the Hollow from Ellesmere Road.*' The amendment was agreed and the revised minutes were then approved and signed by the Chairman as a true record.

**25/35 Matters Arising:**

- (a) Affordable Housing project.

It was noted that Shropshire Councillor S. Marston had discussed this with a representative of STAR Housing, who felt that there could be a road issue with the development and had promised a report by the end of July but to date there had been no further response.

(b) Harmer Hill Footpath 67A.

The Chairman reported that only three Members of the Council had attended the site meeting with Shropshire Council's Rights of Way Officer and no decision had been reached. It had been agreed to bring the issue back to this meeting for the full Council to decide if the residents should be allowed to close the small section of the path.

Councillor R. Jones outlined his opposition to the plan and responded to some of the earlier statements made by the applicant in the public session.

A proposal was made stating that the Council should support the closure of the path, this was seconded and the subsequent vote resulted in three Members supporting it and four Members opposing it. The Clerk was asked to inform Shropshire Council's Rights of Way Officer of the Council's decision.

(c) Myddle Woodland Area:

Members had been forwarded a report from Councillor J. Jackson outlining the various actions she had taken but indicating that progress was limited until attempts to re-open discussions about a possible 100 year lease on the land had been undertaken. Contact had been made with the Acquisitions Surveyor at Shropshire Council who had promised to carry out an investigation.

(d) The Hollow, Harmer Hill:

Shropshire Councillor Marston reported that she had received a positive response from a representative of the highways department who felt that a temporary closure part of the way along the road would be the best solution. Consultation with local residents was essential before any decision was made.

Members supported the suggestion and Councillor Marston agreed to continue with the negotiations.

(e) Harmer Hill Reservoir:

It was understood that a team of police officers and dogs had recently visited the site but there was no report of any action having been taken. The new enforcement officer had indicated that he was intending to visit the site.

It was noted that concerns continued to be raised regarding speeding vehicles on Wem Road, Harmer Hill, The Area by Myddle School and Baschurch Road (Myddle to Myddlewood). It was understood that Shropshire Council are undertaking a full review of speed limit controls and it would be sensible to seek their advice before any action was undertaken.

### **25/39 Possible Projects:**

- (a) Improvements to Myddle Play Area with the possibility of including some adult fitness equipment.
- (b) Tree planting at various locations.
- (c) Installation of Charging Points for electric cars.

### **25/41 Planning Issues:**

1. Barns at Hill Farm, Newton on the Hill – prior approval for change of use from agriculture to two dwellings (25/02406/PMBPA). *Application rejected by Shropshire Council*
2. Smallbrook School, Sleaf – Application for prior approval for the installation of roof mounted solar panels (25/02464/PSPPA). *Application supported.*
3. Land at Webscott Farm – erection of a General Purpose Agricultural Building (25/02962) – *For information only.*

Concerns raised about a development in The Pines Area, Lower Road, Harmer Hill have been reported to Planning Control at Shropshire Council to see if the development needs planning approval. *This is now subject to a planning enforcement investigation.*

It was reported that an appeal had been made regarding Shropshire Council's refusal to permit the construction of a tennis court on land at Roden Farm Barn
