MYDDLE BROUGHTON AND HARMER HILL PARISH COUNCIL DRAFT MINUTES OF THE COUNCIL AGM HELD IN HARMER HILL VILLAGE HALL ON MAY 14TH. 2025 AT 7.30 pm.

Public Session:

There were five members of the public present and the following issues were raised: Affordable Housing Project:

An update of the scheme was requested and the Chairman reported that there had been no further developments. The area in question had been offered for sale to Shropshire Council for the erection of a small unit of affordable properties for local people to rent. To date, Shropshire Council has not agreed to purchase the land. If and when the project went ahead, a local committee would oversee the proposals, which would then be subject to the legal planning application regulations.

Speed Control on Wem Road, Harmer Hill;

Concerns were expressed about the traffic speed along the road, with a request for a 30mph limit to be installed. The Chairman stated that discussions had been held with Shropshire Council and Police representatives, but after detailed checks had been carried out, neither of them was prepared to support the request.

Advertising applications for planning projects.

It was confirmed that anyone seeking planning approval for a development had a legal obligation to put up notices giving details of the proposed plans.

(d) Myddle Village Hall Car Park – repair.

Councillor Greg Miller reported that a contract for the resurfacing of the car park had been agreed and he was hopeful that work would start in the very near future.

(e) Harmer Hill Reservoir – Enforcement Order:

It was noted that no action had been taken to activate the enforcement order and it appeared from reports that additional development had taken place. Shropshire Councillor Sarah Marston was given a brief outline of the problem and promised to investigate it in detail.

(f) Harmer Hill Footpaths.

It was noted with concern that several permissive paths had been removed and that Mr. Philip Bamber from Shropshire Council had asked for a site meeting with Councillors to discuss an application from a landowner to remove a designated footpath. The clerk was asked to arrange a convenient date for this meeting.

(g) Myddle Youth Club.

The newly formed Club has just started activities, which have been well supported by young people. It was agreed to monitor the progress of the Club and give advice or help if it was needed. Shropshire Youth Association was aware of the new Club and gave support.
